In this regard, Hon'ble NCLT vide its order dated 21 December 2022 (written copy received on 23 December 2022), has allowed the extension of 90 days beyond 180 days CIRP timelines for completion of CIR process of the Corporate Debtor.

IA/1090(AHM)2022

This application is filed by the RP producing on record the report of the constitution of the CoC. It is taken on record. Hence, IA/1119(AHM)2022 stands disposed of.

IA/1119(AHM)2022

This application is filed by the RP for putting on record facts that HDFC has assigned its debt to Asset Reconstruction Company (India) Ltd. (ARCIL) and also in favor of Taurus Commodities General Trading LLC.

We noted the facts. In view of this, IA/1119(AHM)2022 stands disposed of.

IA/1128(AHM)2022

This application is filed by the RP for the first extension of 90 days beyond 180 days as the CIRP is going to be over on 18.12.2022

We allow the extension of 90 days from 18.12.2020. As far as the second prayer of exclusion is concerned, we direct the RP to file a separate application, in case, the CIRP could not be completed within the extended period. With this, IA/1128(AHM)2022 stands allowed and disposed of.
